INTRODUCTION

1. This prospectus is to furnish sufficient information in addition to that contained in the published advertisement, to enable prospective bidders to decide whether further investigation of the sale is warranted. Any questions concerning volume estimates and determination procedures, or anything else relevant to this sale, should be addressed to the Gogebic County Forestry and Parks Commission Office.

BIDDING

2. This is a sealed bid "mill scaled" sale. Bids must be submitted on the attached bid form. The bid form contains instructions for submission and the bid deposit guarantee. The Forestry and Parks Commission reserves the right to reject any and all bids. Bids that do not meet the minimum acceptable rates will be rejected.

LOCATION OF SALE AREA

3. The timber sale is located in Wakefield Township, approximately 3.5 miles northeast of County Road 519 on Camp 4 Road then ½ mile east on Turpeinen Grade to private woods road. (See Sale Location Map). The timber sale contains approximately 223 acres to be harvested. The timber sale is located in parts of Sections 35 & 36 T49N-R45W.

DESCRIPTION OF HARVEST PRESCRIPTION

4. Selective Cut Area (223 Acres): Cut all trees marked on the trunk and stump with orange paint. Aspen, White Birch, White Spruce and Balsam Fir are designated to be cut. Sale area is bound by Red and Blue paint.

VOLUME AND DESCRIPTION OF TIMBER

5. The Sale contains the following species and volumes:

115 MBF of Sugar Maple Sawlogs.
110 MBF of Mixed Hardwood Sawlogs.
2,145 CDS of Mixed Hardwood Pulpwood.
125 CDS of Basswood Pulpwood.
30 CDS of Mixed Softwood Woodsrun.
50 CDS of Aspen Woodsrun.

CONTRACT

6. The contract will contain all provisions that will be required of the successful bidder. A sample contract will be available for inspection at the Forestry and Parks Office. The contract will be issued for a period of two (2) operating seasons from the date of awarding. Normal operating season is July 1 – March 31.

LOGGING AND EQUIPMENT RESTRICTIONS:

7. Equipment and/or logging practices, which in the opinion of staff will cause excessive damage, will be prohibited from use on this sale.

ROADS

8. There exists a network of roads to access the sale area.

PAYMENTS

9. Payment for the timber removed will be based on Mill Scale. A bid deposit of 10% will be required and must accompany the bid to be applied to the purchase. Failure to exercise the contract will result in loss of the bid deposit. Purchaser must have on deposit 50% of the total bid value on or before 7/1/2022 and 100% of the total bid value on or before 6/30/2023.

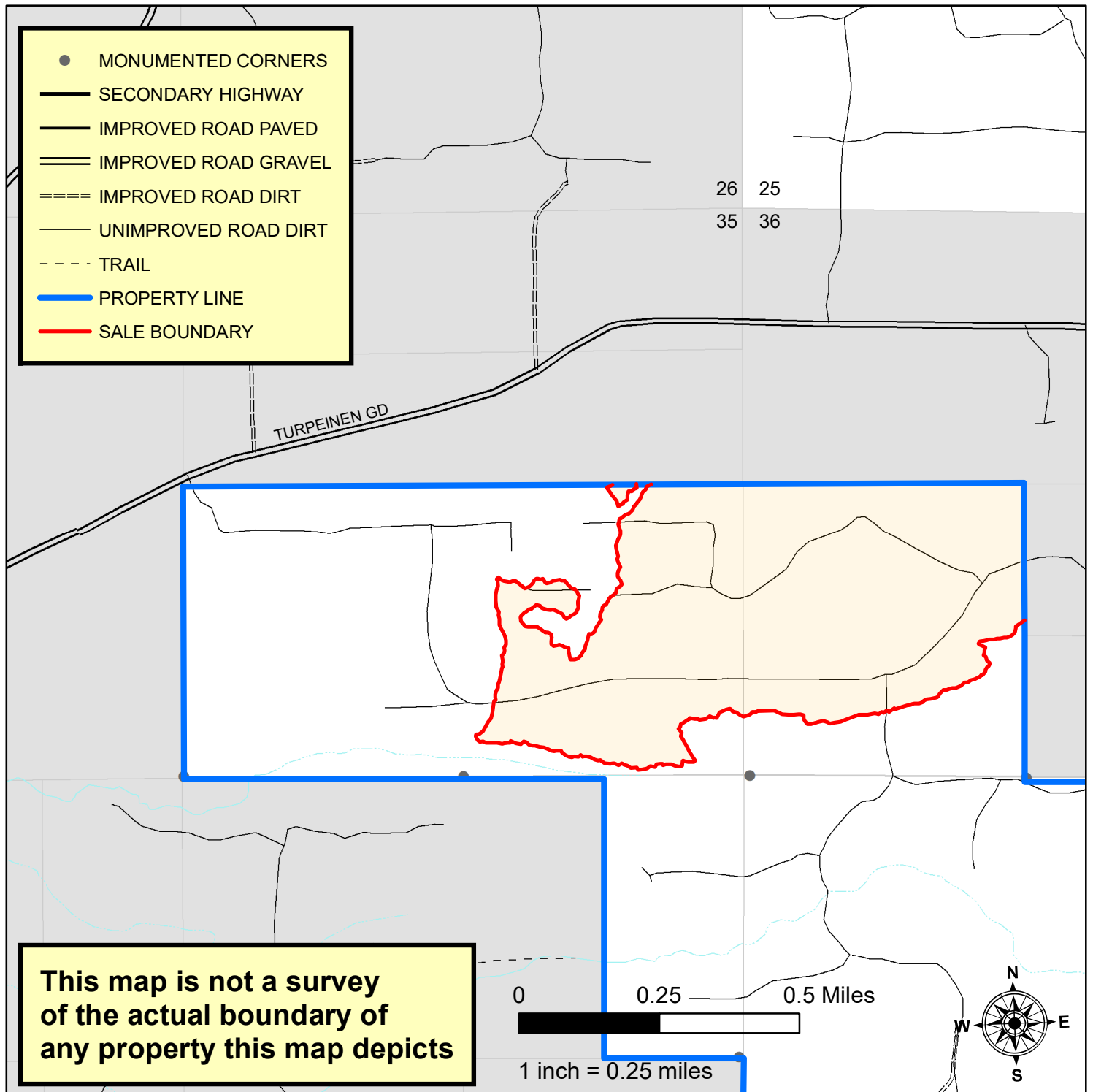
PERFORMANCE BOND

10. A performance bond in the amount of five percent (5%) of the total bid value will be required of the successful bidder. This may be submitted in cash, surety bond or an irrevocable letter of credit acceptable to the Commission.
